## Circular

Upon review of the prevalent COVID-19 situation, West Bengal Government has issued notification regarding banking transaction hours and banking holidays. As per notification of the West Bengal government vide no. 2259 –F(P2) dated 20<sup>th</sup> July 2020, letter of Additional Chief Secretary, Finance Department, Govt. of West Bengal dated 20<sup>th</sup> July 2020 and subsequent correspondence of the State Level Bankers Committee, West Bengal, following alteration will be implemented regarding banking holiday and transaction times with effect from 22<sup>nd</sup> July 2020.

- 1) As per notification of state government, hence all Saturdays will remain close and will be treated as public holiday under N.I. Act till 2<sup>nd</sup> week of August 2020.
- 2) There will be customers' transaction times of 4 hours with five working days including Sunday.

Revised and rescheduled Customers' Transaction hours of the bank with effect from 22/07/2020 are as under.

Sunday will be treated as full working day and above cited transaction hours will be followed.

As usual Monday will be the weekly holiday of the Bank.

This revised and rescheduled transaction time may be changed and revised from time to time on the basis of further notification / circular / advisory of the state government and regulatory authorities.
